"Recycling, conservation and innovation are at the heart of our 'Green as it Grows' program," he said. "One aspect of the program emphasizes reducing chemical use on our farms and ultimately our carbon footprint. Using steam to sterilize soil, IPM (integrated pest management) programs, specialized crop rotation cycles, and organic fertilizer together with effective micro-organisms has helped Farmers' West effectively reach some of these goals."

Farmers' West is committed to conserving water and helping protect local ocean estuaries. It uses drain water from hydroponically grown Gerberas as a nutrient and water source for our other crop, and reduces runoff using sediment and drainage ponds which have created small wildlife sanctuaries. Recycling of all green waste products into compost helps

develop rich, healthy soil that slows water and nutrient runoff. “I am so proud of how our company has addressed water issues” said Wilja Happé . “We all enjoy our local beaches. We all have children that swim and surf. It is important to us to keep our fields green AND our oceans blue.”

Farmer’s West is consistently looking for new solutions and innovations that will add value and improve quality. “Our latest program includes testing the vase life of all of our flower varieties to determine the best post harvest treatment options,” said Will Stewart. He explained that the information Farmers’ West receives from its testing will ultimately result in customers receiving flowers that have been given the absolute best, scientifically proven post-harvest treatment to ensure the best quality and the longest possible vase life.

“The VeriFlora Certification is proof of our commitment to quality,” said Maximino Santillan, CEO of Farmers’ West. Farmers’ West has four growing locations on the Central Coast of California with over 1.5 million square feet of cut flower production.
